CANYON PET HOSPITAL BOARDING POLICY

Boarding is a service we provide for the convenience of our clients. If, while your pet(s) are staying at Canyon Pet Hospital, the doctors feel that medical services are needed, we will call the emergency number(s) you have provided regarding your pet's symptoms, treatment options and estimate of additional costs. If you are unable to be reached, your pet(s) may be transferred to our hospitalization ward and treated. Fees for these services will be charged according to our regular hospital fees and are not included in the boarding price. In the event you pet(s) require emergency medical attention, we may need to immediately stabilize him/her prior to contacting you. Minor problems such as diarrhea will be treated with medication without contacting you and often do not require hospitalization. Occasionally, tranquilizers may be given for excessive barking, cage fright, aggressiveness, etc. There is an additional fee for any medication administered.

VACCINATIONS

Current vaccinations are required for your pet(s) prior to boarding. These vaccinations are required for the protection of all of our boarding pet(s). ***Canyon Pet Hospital will administer necessary vaccines if they are not current or you cannot provide proof that they are current and administered by a licensed veterinarian. An examination may be required prior to administration of vaccinations.*** There is an additional fee for vaccinations and examinations not included in the boarding price. If you do not wish to vaccinate your pet, you must make an appointment with one of our veterinarians prior to boarding to discuss this issue. If there are medical reasons not to vaccinate and your pet is considered healthy on exam, the attending veterinarian may waive vaccinations. Current rabies vaccination for dogs is required by state law and may not be waived. *The vaccinations we require are:*

FOR DOGS: DHPPC, Rabies & Bordetella (every 6 months)

FOR CATS: FVRCP/Felv, Rabies & Bordetella (every 6 months)

HOURS

Canyon Pet Hospital's boarding pick up and drop off hours are between 8am and 6pm Monday thru Friday and between 9am and 6pm on Saturday. If you pick up your pet(s) on Sunday or after 6pm Mon-Sat, you will be charged for that night of boarding. If you need to pick up on Sunday then you must do so between the hours of 2pm and 5pm. There will be nobody available after 5pm for pick up. If you drop your pet(s) off outside of the above boarding hours, you will be charged a "late drop off fee" of \$10.

AUTHORIZATION

I have read and understand the above information. I also understand that trained personnel are not in the clinic beyond regularly scheduled business hours to attend to boarded or hospitalized animals. I agree to pay all fees incurred while my pet(s) are being cared for at Canyon Pet Hospital at the time of his/her release.
